

RELEASE AND WAIVER OF LIABILITY

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____, 2015, by (the "Volunteer") in favor of St. John's Presbyterian Church (hereinafter referred to as "SJPC") and Pen Oaks LLC, Suburban Management Co., Inc. and American Expo Corp. (hereinafter collectively referred to as "AEC") as well as their respective directors, officers, employees, and agents.

The Volunteer desires to work as a volunteer for SJPC and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities are limited to the "Builder's Competition" event to be held at the Greater Philadelphia Expo Center facilities located in Oaks, Pennsylvania, which facilities are owned and/or managed by AEC, to benefit the Philadelphia Area Habitat for Humanity housing needs.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless SJPC and AEC as well as their respective directors, officers, employees, agents, successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with SJPC.

Volunteer understands that this Release discharges SJPC and AEC as well as their respective directors, officers, employees and agents from any liability or claim that the Volunteer may have against SJPC and AEC as well as their respective directors, officers, employees and agents with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with SJPC whether caused by the negligence of SJPC and/or AEC. Volunteer also understands that SJPC and AEC do not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment. Volunteer does hereby release and forever discharge SJPC and AEC as well as their respective directors, officers, employees and agents from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with SJPC.

Assumption of the Risk. The Volunteer understands that the Activities include work that may be hazardous to the Volunteer, including, but not limited to, the use of power tools, construction, loading and unloading, and transportation to and from the work sites.

Volunteer hereby expressly and specifically assumes the risk of injury or harm from the Activities and releases SJPC and AEC as well as their respective directors, officers, employees and agents from any liability for injury, illness, death, or property damage resulting from the Activities.

Insurance. The Volunteer understands that, except as otherwise expressly agreed to in writing, neither SJPC nor AEC maintain any health, medical, or disability insurance coverage for any Volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release. Volunteer does hereby grant and convey unto SJPC all right, title, and interest in any and all photographic images and video or audio recordings made by SJPC during the Volunteer's Activities, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Pennsylvania, and that this Release shall be governed by and interpreted in accordance with the laws of the Commonwealth of Pennsylvania. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
